

## **Belin Memorial United Methodist Church BBQ and Fall Festival Crafter's Application Rules 2024**

**PLEASE READ - THERE ARE CHANGES!!**

Come Join Us for the "Belin UMC BBQ and Fall Festival" on Saturday October 12, 2024, at Belin Memorial United Methodist Church, Murrells Inlet, South Carolina. This event combines art, crafts, food and fun.

1. All work must be ORIGINAL, and Handcrafted. An item must be attributable solely to the displaying artist or craft person. We reserve the right to remove any exhibit if it does not reflect our standards. We reserve the right to limit the number and types of entries. **Food & Baked goods are not to be sold.**

2. ALL spaces will be OUTSIDE. **EARLY BIRD SPECIAL - \$75.00 per space (12x12).** After August 30, 2024 price will increase to 100.00. **DEADLINE TO REGISTER IS OCTOBER 1, 2024 or when all spaces have been reserved.** You may set up your canopy, table and chairs on FRIDAY, OCTOBER 11, 2024 after 6 pm. Please bring something to secure your canopy (cement blocks, etc.). **All craft vendors will need to be set up by 8:00 am on Saturday. All vehicles will need to be removed by 8:15 am. The road will close at 8:30 am.** We are not responsible for damage caused by wind blowing over your items or tent and/or causing damage to another crafter.

3. A South Carolina Retail Tax License is required unless you qualify for exemption. Participating vendors' license information will be reported to South Carolina of Revenue. Each vendor must have their license available at the BBQ Festival for examination. You will not be able to sell at the BBQ Festival without a license. (License is not required if you have documentation of being exempt.) The BBQ Festival is a Special Event Tax Event. Each exhibitor is responsible for collecting sales tax.

4. Applications will be processed as we receive them. **FIRST COME FIRST SERVED.** Include a check or money order made payable to: **Belin UMC –Description BBQ Vendor.** First time vendors must include pictures of exhibits, and a copy of retail license. Spaces will be assigned upon completion of all required documents and application. When spaces are full, you will be added to a waiting list and will be notified as such. IF you are not interested in being on the waitlist, please note that on the bottom of your application.

5. Sorry, we do not provide tables, chairs or electricity. **NO GENERATORS ALLOWED.** Unfortunately, we do not have anyone to assist you in unloading or setting up your tent.

6. This event will NOT be canceled or postponed. Cancellation of this event will ONLY occur if there is a natural disaster (hurricane).

7. Hours for the exhibit will be from 9 am – 3 pm. Exhibitors MUST be set up by 8:30 am.

8. You MUST maintain a display for the entire day. Please do not break down your exhibit before 3 pm.

9. Belin UMC is not responsible for any loss or injury to the exhibitor, their associates or goods.

10. No alcohol, smoking or vaping will be permitted on the premises at any time.
